# APPLICATION FOR BURIAL ON PRIVATE PROPERTY

Burial on private property is regulated by Council Local Law [SLL1.13 \(Undertaking Regulated Activities Regarding Human Remains\) 2011 \(PDF 67.4KB\)](#).

Information and documentation that must accompany this application are:

- Details of the proposed burial site;
- Written authorisations from grave Burial Rights Holder/Next of Kin (if applicable);
- Details of the coffin, container or shroud in which the human remains will be buried or placed;
- Evidence of the applicant's relationship (if any) to the deceased;
- A certified copy of each approval required (including authority under the *Coroners Act 2003* (if applicable)) for the undertaking of the burial;
- Details of how and when the activity will take place;
- Evidence of the identity of the deceased;
- Evidence of the wishes of the deceased and the relatives of the deceased;
- Written agreement of the owner of the land and any other person or entity with a registered interest in the land;
- Details of the long-term family connection to the land, minimum second generation;
- details of the size of the land;
- details of how the applicant plans to secure ongoing access to the site at which the deceased is to be buried;
- A written statement of how and when the remains are to be disposed of; and
- Details of the nature of the ceremony (if any) to be conducted at the time of the burial;

**PLEASE NOTE:** Isaac Regional Council will not prepare the grave. All grave preparation must be undertaken independently, at your expense and under the guidance of a licenced Funeral Director.
