

## **Registration and Renewal**

Registration of your dog is mandatory under the Animal Management (Cats and Dogs) Act 2008. The registration period lasts from the 1st of July to the 30th June. Prorata discounts apply. A renewal will be issued annually. Failure to register or renew the registration is an offence under the Act.

#### **Ownership Transfers**

Please use Isaac Regional Council's 'Transfer of Ownership Agreement' form should you wish to change ownership of a dog.

## Puppy Registration

If you own a dog that is between 12 weeks and 12 months of age, you are eligible for free registration provided that your dog has been microchipped. You will receive a renewal notice the following year.

#### **Reciprocal Registration**

You are eligible to transfer the balance of registration to Isaac Regional Council from another Local Government area. You will need to attach documentary proof from the previous Council indicating the registration is current. No registration fee is payable until a registration renewal notice is issued by Isaac Regional Council.

#### Adoption

Isaac Regional Council's Animal Management Centres have many dogs in need of a loving home. If you are adopting a dog, you will need to pay an adoption fee and registration fee. If they aren't already, any dogs adopted and united with new will be checked for heartworm, owners microchipped and desexed at Council's expense.

#### Pensioner, Veteran and Senior Concessions

If you hold a valid and current Centrelink Pensioner Concession Card or a Veteran Affairs Card, you are entitled to a 50% concession on registration fees. If vour dog has been both desexed and microchipped, you are entitled to free registration, although your registration must still be renewed annually. If you hold a valid and current Seniors Card, you are entitled to a 50% fee concession only if your dog is both desexed and microchipped.

## Canine Control Council of Queensland

You are entitled to a 50% concession fee if you are a member of the Canine Control Council of Queensland (also known as Dogs Queensland).

## Microchipping of Dogs

Microchipping is legally required for all dogs over the age of 12 weeks as a requirement under the Animal Management (Cats and Dogs) Act 2008. Failure to microchip your dog by the required age is an offence under the Act.

## Desexing of Dogs

Desexing of your dog is not mandatory in Queensland but comes with many health benefits for your dog. Generally, it's recommended that you desex your dog unless you are planning to breed. There are significant concession fees for desexed dogs, to encourage responsible ownership of dogs and to prevent unwanted breeding. No discount will be given unless proof of desexing is provided.

#### **Assistance Dogs**

Guide, Hearing and Assistance dogs are entitled to free registration if they comply with the Guide, Hearing and Assistance Dogs Act 2009. You will still be required to register your dog and renew/update your info annually.

## **Government Entity/Working Dogs**

Dogs that are on active duty for a government entity (agency) and working dogs that are kept on rural land and used for work purposes as stated under the Act are exempt from registration.

## Regulated Dogs

Owners of declared Regulated Dogs must indicate the declaration date, type (Dangerous, Menacing, Restricted) and the Regulated Dog Permit No.
