INTRODUCTION

All fees and charges included in Council's Schedule of Fees and Charges have been identified as either Cost Recovery (CR) or Non Cost Recovery (NCR).

Pursuant to Section 97 of Local Government Act 2009.

A Regulatory Fee (cost recovery fee), is a fee for

- a) an application for the issue or renewal of a licence, permit, registration or other approval under a Local Government Act (an application fee); or
- b) recording a change of ownership of land; or
- c) giving information kept under a Local Government Act; or
- d) seizing property or animals under a Local Government Act; or
- e) the performance of another responsibility imposed on the local government under the Building Act or the Plumbing and Drainage Act.

A Commercial Charge (non-regulatory), are charges for commercial transactions where the Local Government is prepared to provide a service and the other party to the transaction can choose whether or not to avail itself of the service.

Examples to Commercial Charges:-

- a) Plant Hire
- b) Sale of Quarry Material
- c) Private Works
- d) Hire of Councils Halls and Venues
- e) Entry to Swimming Pools

The regulatory and commercial fees identified in the Schedule of Fees and Charges have been reviewed by Council.

Isaac Regional Council requires the payment of fees and charges so that some or all of the cost incurred by it in assessing and processing development applications and for the provision of services is recovered. This schedule sets out fees and charges in force effective from 1 July 2024 as adopted by Council on Tuesday 28th May 2024 resolution number 8732.

Purchase of tickets via ticket agencies will incur transaction and merchant fees, which are charged at the discretion of the ticketing platform provider.

FEES AND CHARGES MAY BE VARIED IN ACCORDANCE WITH THE EXCEPTIONAL CIRCUMSTANCES POLICY.

THE FEES AND CHARGES HAVE BEEN SET BY REFERENCE TO EXISTING GOODS AND SERVICES TAX (GST) LEGISLATION AND IN ACCORDANCE WITH AUSTRALIAN TAXATION OFFICE (ATO) RULINGS. COUNCIL RESERVES THE RIGHT TO ALTER THE GST STATUS OF ANY FEE AND CHARGE IN ACCORDANCE WITH ANY CHANGES TO GST LEGISLATION AND TO ATO RULINGS.

PART A3 CLASSIFICATION OF BUILDING AND STRUCTURES

A3.1 PRINCIPLES OF CLASSIFICATION

The classification of buildings and structures or part of a building is determined by the purpose for which it is designed, constructed or adapted to be used. There are essentially 10 building classifications nominated in the Building Code of Australia (BCA). Each part of a building must be classified separately.

A3.2 CLASSIFICATIONS

Buildings are classified as follows:

Class 1:

- a) Class 1a—a single dwelling being a detached house, or one or more attached dwellings, each being a building separated by a fire-resisting wall, including a row house, terrace house, town house or villa unit.
- b) Class 1b—a boarding house, guest house, hostel or the like with a total area of all floors not exceeding 300m2, and where not more than 12 reside, and is not located above or below another dwelling or another Class of building other than a private garage.

Class 2: a building containing 2 or more sole-occupancy units each being a separate dwelling.

Including-

- a) a boarding-house, guest house, hostel, lodging-house or backpackers accommodation; or
- b) a residential part of a hotel or motel; or
- c) a residential part of a school; or
- d) accommodation for the aged, children or people with disabilities; or
- e) a residential part of a health-care building which accommodates members of staff; or
- f) a residential part of a detention centre.

Class 3: a residential building, other than a Class 2 building, which is a common place of long term or transient living for a number of unrelated persons including–

- a) a boarding-house, guest house, hostel, lodging-house or backpackers accommodation; or
- b) a residential part of a hotel or motel; or
- c) a residential part of a school; or
- d) a residential part of a detention centre.

Class 4: a dwelling in a building that is Class 5, 6, 7, 8 or 9 if it is the only dwelling in the building.

Class 5: an office building used for professional or commercial purposes, excluding buildings of Class 6, 7, 8 or 9.

Class 6: a shop or other building for the sale of goods by retail or the supply of services direct to the public, including—

- a) an eating room, cafe, restaurant, milk or soft-drink bar; or
- b) a dining room, bar, shop or kiosk part of a hotel or motel; or
- c) a hairdresser's or barber's shop, public laundry, or undertaker's establishment; or
- d) market or sale room, showroom, or service station.

Class 7: a building which is –

- a) Class 7a—a carpark; or
- b) Class 7b—for storage, or display of goods or produce for sale by wholesale.

Class 8: a laboratory, or a building in which a handicraft or process for the production, assembling, altering, repairing, packing, finishing or cleaning of goods or produce is carried on for trade, sale or gain.

Class 9: a building of a public nature—

- a) Class 9a—a health care building, including those parts of the building set aside as a laboratory.
- b) Class 9b—an assembly building, including a trade workshop, laboratory or the like, in a primary or secondary school, but excluding any other parts of the building that are of another class.
- c) Class 9c— an aged care building.

Class 10: a non-habitable building or structure—

- a) Class 10a—a private garage, carport, shed or the like.
- b) Class 10b—a structure being a fence, mast, antenna, retaining or free standing wall, swimming pool or the like.
- c) Class 10c—a private bushfire.
